1. Recruitment tests consisting of physical, written and oral (for those passing physical & written tests) will be conducted by a recruitment board constituted for the purpose by Police Headquarters, with representative from the Home and P &AR Department.
2. The post reservation for all categories shall be as per the existing Government notification.
3. Candidates eligible and applying for all the posts, option should be given in order of preference i.e., 1st option _____, 2nd option _____, 3rd option _____, 4th option _____.
4. Candidates should furnish recent passport photo/ Xerox copies of educational certificates/ documents, self attested along with the application:
 - a. Academic certificate.
 - b. Indigenous certificate.
 - c. Birth certificate.
 - d. Backward certificate (for backward tribe).
 - e. Tribe certificate.
 - f. Unemployment certificate.
 - g. 4 (four) recent passport photo.

The application with required certificates/ documents should be submitted to Police Headquarters, Nagaland, Kohima, in **Room No. 203** during office hours. Application will be summarily rejected if any of the above certificates/ documents are incomplete/ tampered or forged. Serving Government employees applying for the post should submit NOC issued by concern HOD.

5. Candidates shortlisted for various posts for viva- voce are required to produce original documents/ certificates.

6. Education qualification:

- a. Qualification for the post of UBSI(GD)/ABSI(GD)/ASI(GD)&S.I (Operator) is graduate in any discipline from a recognized university.
- b. For S.I(Technician) - 3(Three) years Diploma in Electronic Computer, Mechanical or Electrical Engineering and above from a recognized university.

7. Age limit:

A candidate for all category of post shall be as per the existing Government notification.


8. Applications sent through Post/ Email or any other Electronic means shall not be accepted.
